Austria	 Karin Kalteis has studied Psychology at the University of Vienna (doctorate in Clinical psychology/ Neuropsychology). She is a licensed Clinical Psychologist, Health Psychologist and Psychotherapist in Austria. She works in a practice for psychology and psychotherapy and is a lecturer of Clinical Psychology at the University of Salzburg. Karin Kalteis is a member of the executive board of the Association of Austrian Psychologists (BÖP) and a member of the Board of Ethics (EFPA).
Cyprus	Maria Karekla , Ph.D. received her doctorate in Clinical psychology with a specialization in anxiety disorders and behavioral medicine from the University at Albany, State University of New York. Particularly, how modern theory-driven approaches, derived from the contextual and behavioral paradigm, such as acceptance and commitment therapy, mindfulness and compassion- focused interventions, can be turned into testable, scalable, and clinically meaningful intervention programs. Beyond his role as a researcher, he has worked independently as a licensed clinical psychologist in private clinic, teacher instructor, mentor to junior researchers and is consulting a heath-tech start-up company . He works as a participant committee member in organizations such as the Pain Alliance Europe and Association for Contextual & Behavioral Science.
